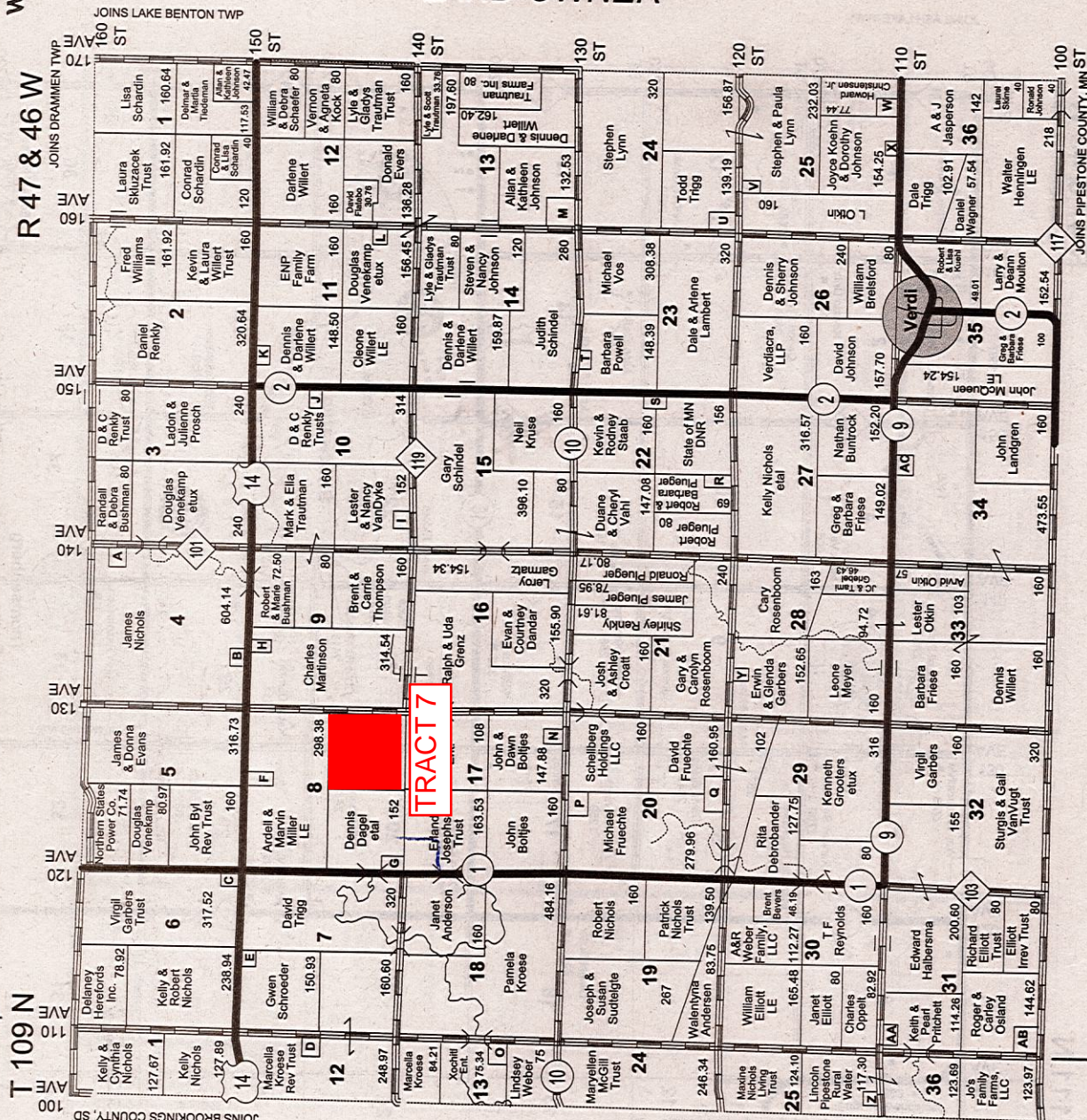




VERDI TWP

LAND OWNER & RURAL RESIDENT MAPS

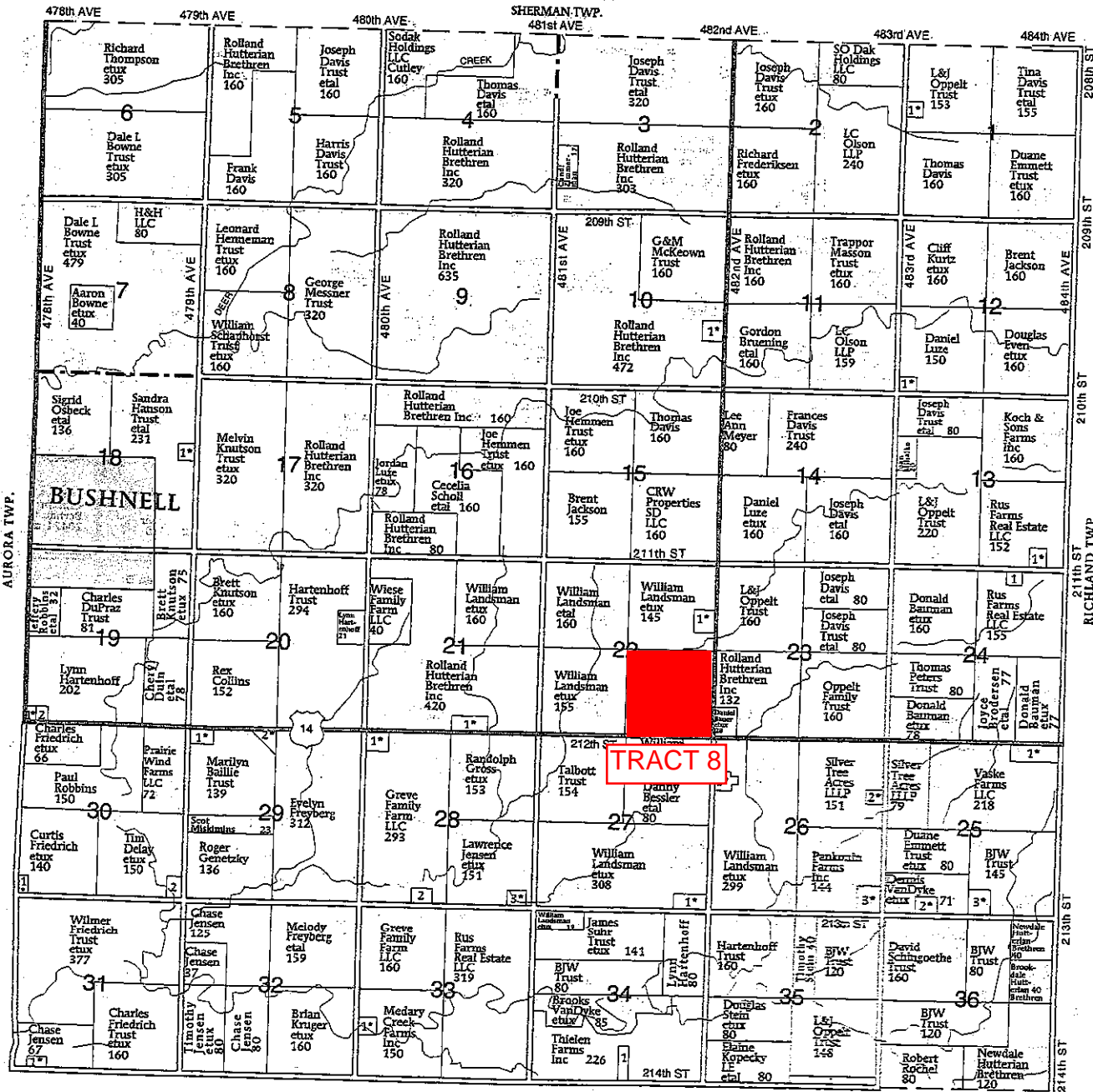
