- 3. That "Seller" "Buyer" (cross out the appropriate party) shall be responsible for completing the upgrade or installation within twelve (12) months of the transfer of the ownership of said property in Lincoln County, Minnesota described herein.
- 4. Both parties understand that in the event the Individual Sewage Treatment System is not upgraded or installed within twelve (12) months of the transfer of

the ownership of said property in Lincoln County, Minnesota, allowing a Certificate of Compliance to be issued, the Ordinance referred to herein may be enforced in accordance with the Lincoln County Comprehensive Development Ordinance; Section XIII Administration; Subdivision 1000.0 Violations, Penalties, and Enforcement.
